- Sehingga, fokuslah sekarang hanya kepada content

- Cek Status dan Standing
- Apakah jumlah artikel tiap terbitan konsisten?
- Apakah artikel direview dengan baik dan benar?
- Apakah alamat fisik jurnal jelas?
- Apakah editorial board memiliki reputasi?

- Scopus memiliki hak untuk menutup coverage sewaktu waktu apabila dirasa proses review sudah tidak berjalan dengan baik. Dan resiko yang paling tinggi adalah Q4
- Problem: Sekarang (2017) masih terindeks Scopus, bagaimana dengan 2018?
- Kita sebenarnya dapat merasakan dari proses reviewnya

- Memilih jurnal yang banyak ditulis penulis dari Asia (tidak menuntut kualitas Bahasa Inggris yang sangat tinggi)
- Mengikuti jejak penulis Indonesia yang lain: “kalau artikel Dia dapat masuk ke jurnal tersebut, maka Saya juga seharusnya bisa”

Tips and Tricks

- Extra Hati-hati dengan publisher negara IPB; example: *Man in India*. Meskipun tidak semua IPB jelek.
- Scopus dari Negara Eropa Timur, Amerika Latin “relatif” lebih aman
- Banyak yang Business Oriented : menganggap Indonesia sebagai pasar
